

2011 Giveaway Rules

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2. SPONSOR: Gearhead Communications LLC Premier Guitar, Three Research Center, Marion, IA 52302. "Sponsor and its agents" shall mean Gearhead Communications LLC Premier Guitar, its advertising/promotional and/or fulfillment agencies and their respective parent companies, affiliates, subsidiaries and their respective employees, officers, directors and agents. Sweepstakes Administrator shall mean: Gearhead Communications LLC Premier Guitar, Three Research Center, Marion, IA 52302.

3.
